The inks used for the production of these cups are low migration inks and comply with the "EuPIA Guideline on Printing Inks applied to the non-food contact surface of food packaging materials and articles" and "CEPE- EuPIA Good Manufacturing Practices for the production of food packaging inks." Furthermore, the inks comply with Swiss Ordinance 817.023.21.

The analyses for toxicological risk assessment carried out on decorated cups showed the absence of dangerous substances for human health.

Type or types of food these products are intended to come into contact with:

Watery, acid, alcoholic (up to 8%) and dairy

Filling with hot drinks maximum temperature: 100°C

Contact time: 20 minutes (temperature decaying)

Comments: Do not use in traditional or microwave oven. Not suitable for cooking.

The limit of the global migration together with all other specific restrictions to which monomers and additives contained in the material might be subject, is fulfilled in the use directions above mentioned. This statement is supported by analytical tests or based on theoretical calculations about migration of substances performed in accordance with directives DM 21st of March 1973, where applicable.

Calculations have been made considering that 1 kg of food get in touch with 6 dm² of product.

This statement is issued according to the legislations cited above and is intended to:
