7. Users of material indicated in this declaration in the industrial or commercial field do not preclude the assessment of its compliance with the rules of competence and technological suitability for the purpose intended.

8. This declaration is valid from the date below and will be replaced in the case involving substantial changes in the production of the article which could change some essential requirements for compliance or when legislative references cited in this Declaration will be amended and updated so that a new compliance verification is required. This statement has anyway a temporal validity of maximum 36 months."
