Product identity

Disinfectant wipes for hands, objects, food surfaces. Wipes impregnated with hydroalcoholic solution.

Benefits

Manual

TP1 HANDS Rub the hands with the wipe, distribute well and rub for 30 s to 60 s depending on the desired effect. Do not rinse. Repeat the operation several times a day.

TP2 SURFACES

TP4 FOOD SURFACES Scrub clean surfaces. Let dry. Do not rinse.

Precautions for use

Sensitive materials (covering paints, varnishes, certain plastics, etc.) : test on a small, invisible area before using the wipes. Do not leave more than 10 minutes on surfaces.



DANGER

Highly flammable liquid and vapor. Causes serious eye irritation. Keep out of the reach of children. If you consult a doctor, keep the container or the label are available. Wear protective equipment eyes. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if the victim door and if they can be easily removed. Continue to rinse.
