I. PRODUCT DESCRIPTION

Seni Active Trio elastic disposable underwear are designed for people with heavy urinary incontinence. Top and bottom layers are made of soft non-woven. Absorbent core is made of cellulose pulp combined with superabsorbent beads. Contains distribution layer (EDS). Antileakage protection is provided by side standing gathers along absorbent core and leg cuffs with elastic yarn in groin area. Wetness indicator - black, printed inscription that fades when exposed to wetness. Vapour permeable outer layer on the whole surface. Z-fold tape in back area to be wrapped around the underwear after use.

II. RAW MATERIALS

Cellulose, hydrophilic nonwoven, hydrophobic nonwoven, distribution layer (EDS), vapour permeable film, elastic yarn, hot-melt adhesives, superabsorbent, Z-fold tape.

The disposable underwear must be placed on wooden pallet, covered by PE sheets from the top and PE sheets or cardboard divider sheet from the bottom and wrapped together with PE stretch film.

VI. RECOMMENDED STORAGE CONDITIONS

It is recommended to store disposable underwear in a dry and well ventilated warehouse at stable temperature between 5° C and 35° C, at humidity $\leq 70\%$ and in their original packagings. The packagings must remain intact without openings in stretch film in order to avoid dust, odour and/or other contamination.
