Isopropyl Palmitate, Caprylic/Capric Triglyceride, Zinc Oxide, Canola Oil, Cera Microcrystallina, Dicaprylyl Carbonate, Butyrospermum Parkii Butter, Polyglyceryl-2 Dipolyhydroxystearate, Hydrogenated Castor Oil, Petrolatum, Silica, Linum Usitatissimum Seed Oil, Olea Europaea Oil, Tocopheryl Acetate, Glyceryl Stearate Citrate, Panthenol, Saccharomyces Ferment Filtrate, PEG-8/ Tocopherol/ Ascorbyl Palmitate/ Ascorbic Acid/ Citric Acid.
